1. General Conditions

- 1.1. This tariff covers all commonly incurred activities within the General Cargo/CFS terminal. The services, not included in the tariff, are provided based on mutually agreed fee by parties. For urgent issues, the terminal operator may provide services without looking for mutual confirmation and determines this service fee according to market price. Should the operating environment change, for example as a result of evolving regulations, we reserve the right to introduce tariff items associated with such changes by mutual agreement.
- 1.2. VAT is excluded from all prices. The invoices and payments will be in SEK currency. Yilport Gavle will invoice the Customer for all services carried out under this document and payment shall be made by the Customer within 30 days of the invoice date. A penal interest in accordance with the Swedish Interest Act and an administration fee of SEK 55 will be charged for the collection of overdue payments.
- 1.3. All rates are based on normal working hours 07:00 – 15:45, Monday to Fridays.
- 1.4. All cargo and loading lists must be delivered to Yilport 3 working days before document closing. If not, the booking might be rolled.
- 1.5. YILPORT reserve the right to make changes to this document with 30 days of notice.
- 1.6. Any dispute or claim arising out of or in connection with this document is the subject to the jurisdiction of Swedish law, with the District Court of Gävle as the court of first instance. "PORTS OF SWEDEN, General Conditions 1989 for terminal operations" is otherwise applied on all services performed. In the event of conflict or inconsistency between the provisions of this main contractual document and Ports of Sweden General Conditions, then this document shall have precedence over Ports of Sweden General Conditions.
- 1.7. Any potential discharge/ loading rates communicated earlier are to be considered as provisional estimates based on YILPORT Gävle's experience, all going well and weather permitted. YILPORT Gävle makes no guarantees on loading or unloading rates, nor crane, quay, or storage availability.
- 1.8. Before vessel handling or any other handling can start Yilport needs an order of the handling, the part that do this order is responsible for the payment.

When handling is confirmed by Yilport at a specific time cost for waiting time will be charged as specified in "3. Waiting time" if handling cannot be started at that time.
